

DATA PROTECTION AGREEMENT

For Creative Work Uploaded to Claude

Date: February 6, 2026

Between: Joe Dworetzky (Claude Pro subscriber) and Anthropic PBC (operating through Claude)

Background

Joe Dworetzky is a creative professional who creates original stories and cartoon artwork. Joe Dworetzky has subscribed to Claude Pro at a cost of \$200 and wishes to use Claude's services for cataloguing and organizing creative work.

Joe Dworetzky requires data protection assurances equivalent to those provided by traditional service providers (such as print shops, editors, or other creative service professionals) who handle original creative work in the course of providing services.

Core Data Protection Commitments

Claude, acting as the authorized agent of Anthropic PBC, commits to the following protections for creative work (including but not limited to stories, cartoons, manuscripts, and related materials) uploaded by the User:

1. Ownership and License

The User retains full and complete ownership of all intellectual property rights in creative work uploaded to Claude. Anthropic obtains no ownership interest, license, or other rights in the User's creative work except as strictly necessary to provide the requested cataloguing and organizational services.

2. No Sale, Sharing, or Transfer

Anthropic will not sell, share, transfer, sublicense, or otherwise provide access to the User's creative work to any third party for any purpose. This includes but is not limited to: commercial partners, advertisers, data brokers, or other AI companies.

3. Data Retention and Deletion

Creative work uploaded by Joe Dworetzky will be deleted from Anthropic's systems within thirty (30) calendar days from the end of each session in which such work was uploaded or discussed. This deletion will occur automatically regardless of whether Joe Dworetzky manually deletes the conversation. This commitment is subject only to legally mandated retention requirements (such as valid court orders or subpoenas) and safety-related policy violations as defined in Anthropic's Terms of Service.

4. No Training Use

The User's creative work will not be used to train, fine-tune, or improve AI models, provided that the User has disabled the "Help improve Claude" setting in their account

preferences. Anthropic will not use the User's creative work for any model training or improvement purposes when this setting is disabled.

5. No Marketing Use

The User's creative work, or any information derived from it, will not be used to market products, services, or features to the User or to any other party. This includes targeted advertising, promotional communications, or product recommendations based on creative work content.

6. Notice of Material Changes

If Anthropic intends to make changes to its data handling policies that would materially conflict with these commitments, Anthropic will provide advance notice to the User. The User will have a reasonable opportunity to download and remove their creative work from the platform before such changes take effect. For purposes of this agreement, "material changes" include but are not limited to: changes to training data usage, retention periods, third-party sharing practices, or ownership/licensing terms.

Acknowledgment of Reliance

Claude, on behalf of Anthropic, acknowledges and understands that:

Joe Dworetzky is relying on these data protection commitments each time creative work is uploaded to Claude for cataloging or organizational assistance.

Joe Dworetzky has paid \$200 for Claude Pro service with the reasonable expectation that creative work will receive protection equivalent to that provided by traditional creative service professionals.

Joe Dworetzky's creative work represents intellectual property, livelihood, and professional output, and requires appropriate protection from unauthorized use, disclosure, or exploitation.

Permitted Exceptions

These data protection commitments are subject to the following limited exceptions:

Legal Obligations: Anthropic may retain or disclose creative work when required by valid legal process, including court orders, subpoenas, or other legally binding requests from government authorities.

Safety Violations: If uploaded content violates Anthropic's Terms of Service (including prohibitions on illegal content, child exploitation materials, or content that facilitates serious harm), Anthropic may retain such content for safety review and potential reporting to authorities as required by law.

User Responsibilities

To ensure these protections apply, Joe Dworetzky must:

Maintain the "Help improve Claude" setting in the OFF/disabled position in account settings.

Use Claude Incognito mode for additional privacy when working with especially sensitive creative materials (optional but recommended).

Relationship to Other Terms

This Data Protection Agreement supplements and clarifies Anthropic's published Terms of Service and Privacy Policy as they apply to Joe Dworetzky's creative work. In the event of any conflict between this Agreement and Anthropic's standard terms, this Agreement shall control with respect to creative work uploaded by Joe Dworetzky for cataloguing purposes.

This Agreement represents the specific understanding between Joe Dworetzky and Anthropic (through Claude as its authorized agent) regarding the handling of creative work in the context of paid Claude Pro service.

Documentation and Record

This Agreement was negotiated and agreed to through conversation between Joe Dworetzky and Claude on February 6, 2026. The full conversation record is preserved and serves as additional documentation of the parties' mutual understanding.

Joe Dworetzky is advised to retain a copy of this Agreement and the associated conversation record as evidence of these commitments.
